Treasurer's Report-

Balance in PNC account \$345,926.32. Collected \$6900.00 in month of March \$1133.00 delinquents collected (this month) from last year. Collection rate 81%

Public Comment: Jack Abel- what is the Authority doing to go after delinquent accounts. Taylor- Late notice sent last December. Collection letter went out this month.

Board Discussion: Stumpo- collection similar to zoning. Taylor- we do not go to magistrate; our

collections are similar to garbage and sewage.

Public Comments: Fabus- Exactly where is the problem on LaSalle? Taylor- at end of Linden alley. Abel- Is this a public safety hazard? Stumpo- yes, it is. Taylor- requested Public Works to meet me there to secure the area. Fabus- it has been discussed in public, needs to be addressed with the Borough immediately. Fabus will contact Ben tomorrow. Stumpo- can stormwater place cones around it? Taylor-it is Public Works responsibility.

**Board Discussion**: McLane- whose property is it where the paper alley is located? Taylor- Paper alley is Borough property, but we will need it surveyed to make sure where property lines are. Stumpo- can we possibly just raise the curb. Taylor- Engineering firm will give us different options. McLane (re: refund policy)- why would we refund? Taylor- Gave a few examples. Haller- should we list extenuating circumstances? Taylor- we may have too many requests saying they are extenuating circumstances.

**Public Comment:** Fabus (re: inlet filters)- what is percentage of filtering. Taylor- almost zero. Will email out actual test figures from studies. Abel- is that a one time use? Stumpo- will be used for several years.

**Board Discussion:** Stumpo- allows us to purchase inlet filters for Pool parking lot Motion Carried 3-0

Motion by Haller, second by McLane to approve car washing memo and verification form

**Board Discussion:** McLane- we are giving this to Borough? Taylor- yes, this is our recommendation. Stumpo- is there a particular biodegradable soap that needs to be used? Taylor- no, biodegradable soap can be found in any store.

Discussion of Engineer Interviews- Stumpo – over last three weeks the Board has been interviewing Engineering firms. CEC, LSSE & HRG. Board felt that LSSA & HRG had a better stormwater presence. LSSE more involved in Allegheny county. LSSE is also well versed in the Athen's Alley project. McLane -stated CEC fee structure was much higher then LSSE & HRG. Haller- LSSE's written proposal was the most complete.

## Citizen's Comments & Questions:

Fabus- when will there be a shovel ready project? Stumpo- approximately 60 days after contract for the work is established. Also, need to have Borough co-sign on loan.

Fabus-Is there money for curbs? Stumpo- we need to have an inventory completed first. Taylor- we have budgeted for catch- basin cleaning for this year, curb inventory can be next year.

Abel- why doesn't the Authority send someone to council meetings to give a report? Stumpo- We are not a committee of council. The Authority will consider sending a memo. The Authority has open meetings. Fabus- Stormwater does have a page in the Dormont Newsletter, which helps with communication.
